

Documenting Recovery Outcomes

- Developed and implemented a recovery retention framework: Secondary Analysis of RH data (15 years)
- Pilot-tested the RMS outcomes protocol with rural RH in West Virginia
- Scoping Review to determine the predictors of retention within RH and further inform RMS outcomes protocols

Determining State Level Support and Plans for RH

Developed a survey and partnered with the National Association for State Alcohol and Drug Abuse Directors (NASADAD) for dissemination among 50 state agencies. 2

Assessing the Impact of COVID-19 on Recovery Housing

Completed a 2020 national survey assessing the impact of COVID on RH and conducted a follow-up mixed methods study to identify current impacts and needs of NARR Recovery Homes.

Understanding the Barriers of Physicians Treating Patients with a Substance Use Disorder

Completed a pilot study among Kentucky physicians and conducted a national study of physicians in ten HRSA states with an improved survey and lessons learned from the pilot.

Evaluating the Implementation of SMART Recovery in RH

Successfully pilot-tested SMART with four Recovery Homes and expanded implementation protocols with improved comprehensive protocols in 100 rural Recovery Homes.
